

PROCLAMATION OF THE TOWN OF PONCE INLET, FLORIDA

WHEREAS, ELECTION AND TERMS: Pursuant to Article III of the Town Charter, a Regular Election will be held for the following positions on the Town Council for two (2) year terms:

- Mayor / Seat #1, presently held by Tony Goudie,
- Councilmember/Seat #3, presently held by Jim McCormick, and
- Councilmember/Seat #5, presently held by Jack Sturno.

WHEREAS, QUALIFICATIONS: Pursuant to Article V of the Town Charter, any person desiring to be considered a candidate for Town Council must meet the following qualifications:

- Resident of the Town of Ponce Inlet for at least twelve (12) months prior to filing,
- Registered voter of Volusia County for at least (6) six months,
- Submission to the Town Clerk of petition signed by at least fifteen (15) qualified electors of the Town requesting that said candidate's name be placed on the ballot in the ensuing election (legal petition form provided from the Town Clerk), and
- Submission to Town Clerk of all necessary forms as required by Town Charter and State Law (available from Town Clerk).

NOW THEREFORE, I, Tony Goudie, Mayor of the Town of Ponce Inlet, Florida, do hereby proclaim the following:

SECTION 1: QUALIFYING DATES AND TIMES: Qualifying for the office of Town Council shall begin Tuesday, September 8th, 2009 at 9:00 a.m. and continue until NOON, Friday, September 18th, 2009.

SECTION 2: TIME AND PLACE OF THE REGULAR ELECTION: The Regular Election shall be held on TUESDAY, NOVEMBER 3RD, 2009 and voting shall be from 7:00 a.m. until 7:00 p.m. at the Community Center, 4670 S. Peninsula Drive, Ponce Inlet, Florida.


SECTION 3: REGISTRATION: Electors must be registered with the Supervisor of Elections, Volusia County, Florida by Monday, October 5th, 2009 in order to vote in this election.

SECTION 4: EQUIPMENT TESTING: The voting equipment to be used in this election will be tested on Friday, October 23rd, 2009, at 9:00 a.m. at the Department of Elections Warehouse, 2550 West Highway 44 – Building 14, DeLand, Florida 32720. The public is invited to attend.
