This Verification Report is provided to explain the recommendations of Insurance Services Office, Inc. (ISO) to DHS/FEMA concerning credits under the Community Rating System (CRS) for the above named community.

A total of 2196 credit points are verified which results in a recommendation that the community improve from a class 7 to a CRS Class 6. The community has met the Class 6 prerequisite with a Building Code Effectiveness Grading Schedule (BCEGS) Classification of 3/3. The following is a summary of our findings with the total CRS credit points for each activity listed in parenthesis:

Activity 310 – Elevation Certificates: The Building Department maintains elevation certificates for new and substantially improved buildings. Copies of elevation certificates are made available upon request. (56 points)

Activity 320 – Map Information Service: Credit is provided for furnishing inquirers with flood zone information from the community's latest Flood Insurance Rate Map (FIRM), publicizing the service annually and maintaining records. (140 points)

Activity 330 – Outreach Projects: A community brochure is mailed to all properties in the community on an annual basis. The community also provides flood information at public buildings. (51 points)

Activity 350 – Flood Protection Information: Documents relating to floodplain management are available in the reference section of the Town of Ponce Inlet Public Library. Credit is also provided for floodplain information displayed on the community's website. (63 points)

Activity 360 – Flood Protection Assistance: The community provides technical advice and assistance to interested property owners and annually publicizes the service. (53 points)

Activity 410 – Additional Flood Data: Credit is provided for conducting and adopting flood studies for areas not included on the flood insurance rate maps and that exceed minimum mapping standards. (29 points)

Activity 420 – Open Space Preservation: Credit is provided for preserving approximately five acres in the Special Flood Hazard Area (SFHA) as open space. Credit is also provided for open space land that is deed restricted. (95 points)

Activity 430 – Higher Regulatory Standards: Credit is provided for enforcing regulations that require freeboard for new and substantial improvement construction, other higher regulatory standards, and land development criteria, special hazards, state mandated regulatory standards, and for enforcing the Florida Building Code. Credit is also provided for a Building Code Effectiveness Grading Schedule (BCEGS) Classification of 3/3 and for staff education and certification as a floodplain manager. (1042 points)

Activity 440 – Flood Data Maintenance: Credit is provided for maintaining and using digitized maps in the day to day management of the floodplain. (104 points)

Activity 450 – Stormwater Management: The community enforces regulations for stormwater management, freeboard in non-SFHA zones, soil and erosion control, and water quality. (228 points)

Section 502 - Repetitive Loss Category: Based on the updates made to the NFIP Report of Repetitive Losses as of September 31, 2007, the Town of Ponce Inlet is now a Category A community for CRS purposes and no further action is required. (No credit points are applicable to this section)

Activity 540 – Drainage System Maintenance: A portion of the community's drainage system is inspected regularly throughout the year and maintenance is performed as needed by the Town of Ponce Inlet Public Works Department. Records are being maintained for both inspections and required maintenance. The community also enforces a regulation prohibiting dumping in the drainage system. (268 points)

Activity 630 – Dam Safety: All Florida communities currently receive CRS credit for the state's dam safety program. (67 points)
